# **Background**

In today's world of deep interdependence and widening inequalities, the pursuit of sustainable development demands renewed global attention. The international webinar on "State, Economy and Society for Sustainable Development" will examine the emerging and re-emerging challenges to achieving the Sustainable Development Goals (SDGs), including humanitarian crises, conflicts, affordability, and vulnerabilities across societies. Despite progress since the adoption of the 2030 Agenda, the implementation of the SDGs continues to face significant hurdles such as inadequate financing, fragmented governance structures, regional and social disparities, and insufficient data for monitoring progress. These challenges underscore the urgency of rethinking development pathways that integrate economic efficiency, environmental sustainability, and social justice.

By focusing on the dynamic roles of state, economy, and society, the event seeks to generate critical insights into pathways of inclusive governance, resilience, and equity. Particular attention will also be given to mental health, community well-being, and grassroots innovations that complement state policies. The role of media and communication in shaping public discourse on sustainability will also be addressed. Equally important is the relevance of reforms, innovations, and evidence-based policies in steering nations toward sustainability. Policy coherence, institutional reforms, and adaptive governance mechanisms are essential for aligning short-term national priorities with long-term global commitments. Innovations in technology, community practices, and governance frameworks must be backed by evidence to ensure that development interventions are both effective and equitable. The event will be followed by an international conference and culminate in an edited international book publication, encouraging collaborative and interdisciplinary research.

- 2.To analyze how economic policies and evidence-based reforms influence sustainable practices in production, consumption, and resource management.

# Final and completed papers may be submitted after the abstracts have been accepted by the editors. A few guidelines are in place at the time of submission:

- 1. The paper should be written in English (UK) and should not exceed 6000 words.
- 2. It should be original, unpublished, and should not have been copyrighted.
- 3. It should not have been presented or accepted for presentation at professional meetings and should not be currently under review for presentation at other professional meetings. A declaration to this effect must accompany the final paper, which must include ethical responsibilities and Standards as well.
- 4. The manuscript should include a separate page containing the following in the order mentioned: title, authors, affiliation, abstract, keywords, main text, acknowledgements, appendix and references.
- 5. The title page should be concise and informative and should include: the names) of the authors), institutional affiliations), addresses of the authors), E-mail, contact address, and telephone numbers) of the corresponding author.
- 6. Authors are requested to submit a camera-ready paper following the prescribed guidelines (see below).
- 7. Authors should take responsibility of content-editing, grammar-check, proof-reading, formatting etc.
- 8. The completed paper may be submitted in Microsoft Word (doc format only) on or before 12<sup>th</sup> March 2026 via email to *panneersigamani@gmail.com*

# The manuscript preparation should be adhered to while preparing the final paper:

# **Text Formatting**

- 1. Manuscripts should be submitted in Word.
- 2. Use a normal, plain font (e.g., 10-point Times Roman) for text.
- 3. Use italics for emphasis.
- 4. Use the automatic page numbering function to number the pages.
- 5. Do not use field functions.
- 6. Use tab stops or other commands for indents, not the space bar.
- 7. Use the table function, not spreadsheets, to make tables.
- 8. Use the equation editor or Math Type for equations.
- 9. Save your file in doc format (Word 2007 or higher) or doc format (older Word versions).
- ${\bf 10.} \\ Manuscripts with mathematical content can also be submitted in LaTeX.$
- 11. Tables should be editable in Microsoft Word easily, i.e., they should NOT be in picture format. Table titles should be concise and exactly to explain what the table shows.

### **About the Organizers**

Centre for the Study of Law and Governance (CSLG, JNU) CSLG was founded in the year 2001 as a response to the need for an interdisciplinary understanding of issues related to the study of law and governance. It has been a decade for the Centre with the development of three attributes- interdisciplinarity, academic rigor and linking of formal legal framework and governance in practice. The Centre draws students from diverse backgrounds, similar to the University. The Centre has successfully attempted pedagogical innovations. Its teaching of optional courses is largely in the seminar format, where students read in advance of the class, making presentations and engaging in discussion in the classroom. The faculty also makes use of audio-visual materials such as documentaries and feature films. In some courses, open-book examinations are also conducted. The normative ideals of justice, equity and freedom thus inflect the Centre's critical interrogations of existing institutions and practices of law and governance. It is in this spirit that, while the Centre's academic programme produces scholarly research in these areas, it also seeks to translate theory into practices of governance by initiating debate, sharing research, and providing a platform for dialogue between the academy, government, civil society, and international agencies.

In the decade since it came into existence, the Centre for the Study of Law and Governance has developed at least three attributes that make it a distinctive part of the intellectual landscape. First, the Centre is explicitly interdisciplinary, as evidenced by the diverse academic training of its faculty and its student body, as well as in the teaching and research programme it has fostered. Second, the Centre has developed a reputation as a location where academic rigour can be meshed with reflection on policy and advocacy. Third, the Centre has become a focal point for understanding the links between the formal legal framework and governance in practice. As with the Jawaharlal Nehru University as a whole, the Centre also draws students from a diversity of backgrounds – regional, socio-economic, and academic. The study of governance, in its various forms and at different sites, is central to several contemporary issues: the reform of public institutions and public law; the creation and establishment of procedures and rules that lead to greater efficiency, transparency, and accountability; and the challenge of making governance more inclusive and participatory through the strengthening of democracy and civil society. The Centre's interdisciplinary focus draws on critical social science approaches in its attempt to explore how practices of law and governance are embedded in political, economic, social and historical processes; how practices of governance are dispersed over various sites ranging from the government, bureaucracy, judiciary, community and family; the socio-legal processes that deter or provide access to justice; and notions of governmentality, sovereignty and rights in specific politico-jural regimes.

The Department of Applied Research, Gandhigram Rural Institute- Gandhigram, was established in 1976 under the Faculty of Rural Development. The Center plays a key role in enabling the Institute to achieve its overall objective of rural development by promoting interdisciplinary, problem solving and development research.
